APPLICABLE INSTRUMENTS and DEGREE OF AUTHORISATION

- a. RS is hereby authorized as listed below to carry out statutory certification services on behalf of the Administration with respect to ships and offshore units, registered in Sri Lanka, equipment and materials for ships and offshore units, including containers. The following two types of authorizations apply as noted:

F: Full authorization to perform review of engineering designs, drawings, calculations and similar technical information, carry out surveys and issue and/or revoke necessary interim and/or full term certificates, including type approval of ship's systems and equipment;

P: Partial authorization to perform review of engineering designs, drawings, calculations and similar technical information, carry out surveys and issue and/or revoke interim and/or full term certificates, including type approval of ship's systems and equipment, subject to specific guidance, conditions or limitations provided by the Administration.
