Item 1: Approval of meeting agenda (SHIF/MC/14/222/AG)

Management Committee (MC) refers to document ref. SHIF/MC/14/222/AG and decides to approve meeting agenda.

Item 2: Amendments to the SHIF Rules for Elections Appendix II to the SHIF Regulations and Administrative Rules (SHIF/MC/2014/222/2)

MC refers to document ref. SHIF/MC/2014/222/2 and decides to approve amendments to the SHIF Rules for Elections (amended SHIF Rules for Elections attached).

Item 3: Other amendments to the SHIF Regulations and Administrative Rules (SHIF/MC/2014/222/3)

MC refers to document ref. SHIF/MC/2014/222/3. MC decides, as a first step, to only amend SHIF Regulations and Administrative Rules to reflect withdrawal of ITU from the Fund and revised Rules for Elections.

MC members will have until 22 May to make final comments on amended Regulations and Administrative Rules as proposed in document ref. SHIF/MC/2014/222/3. If no comments, amended version will be considered as adopted.

Transitory provisions relative to the settlement of ITU claims (until 31.01.2015) remain to be incorporated. Effective date of amended Regulations and Administrative Rules remains to be decided by MC.

Item 4: Information on the agreement with the ITU regarding their withdrawal from the Fund (SHIF/MC/2014/222/4)

MC refers to document ref. SHIF/MC/2014/222/4. Chair informs MC regarding agreement with the ITU regarding their withdrawal from the Fund.

Item 5: Request for SHIF's participation in covering the cost of a specialized school care institution (Special case 01/2014)

MC refers to abstract relative to Special case ref. 01/2014 and continues discussion begun at its 221st meeting on 14 April 2014. MC decides that the SHIF should accede to the insured person's request, in accordance with the Standing Subcommittee's 2011 decision regarding a comparable case.

However, MC also decides that, before they can be considered, future cases submitted to the SHIF that are comparable to the case in relation to which the Standing Subcommittee's 2011 decision was taken will need to be supported by documented evidence that every effort has been made to be eligible for benefits from national social security schemes. These social security benefits will be deducted from the SHIF benefits, as calculated according to the Standing Subcommittee's 2011 decision.

1. Technical results for the period 01.01.2014 - 31.03.2014

MC refers to document ref. SHIF/MC/2014/222/6-1 and notes technical results for 1st Quarter 2014, heavily impacted by IBNR.
