Item 1: Approval of meeting agenda

(SHIF/MC/16/236/AG)

MC refers to document ref. SHIF/MC/16/236/AG and approves the agenda with one modification. Item 3 will be discussed under agenda item 9 "Any other business".

Item 2: Approval of the Record of Decisions of the 235th meeting of the Management Committee (SHIF/MC/16/RD.235)

MC refers to document ref. SHIF/MC/16/RD.235.

At the request of some members representing the insured persons, it is decided to include in the Record of Decisions a general remark on the need for the Management Committee to be consulted for any action that the ILO Administration may consider in relation to SHIF Management. This concerns item 4 "Update on the three working groups of the Management Committee" and item 6.6 "Governing paper on ASHI" of the Record of Decisions.

With that proposed insertion, MC decides to approve the Record of Decisions of the 235th meeting of the Management Committee.

Item 3: External review of the SHIF

(SHIF/MC/2016/236/3)

Item 4: Update on the three working groups of the Management Committee

- **WG on the SHIF Governance**: The WG has not met since the last meeting of the MC. It is agreed that members representing the insured persons will draft a paper that will be presented to the Working Group on the SHIF Governance at its next meeting.
- WG on Cost-Containment: The Secretariat has provided the requested data and a meeting of the WG is planned for Wednesday 6 July. Proposals are expected for the next MC meeting in September.
- WG on the Revision of SHIF Regulations and Administrative Rules: Due to the heavy workload of the Secretariat, it is agreed that the output of the WG will be delivered as soon as possible.

Item 5: Draft circular SHIF/16/2 - Increase in the contribution rates (SHIF/MC/2016/236/5)

MC agrees on the draft circular which will be sent to all SHIF insured persons as soon as possible. A link to SHIF circular SHIF/15/1 of 4 December 2015 will be added.

Item 6: General Meeting of insured persons

The General Meeting of insured persons will take place on Thursday 29 September from 12:30 to 14:30. MC discusses the agenda items for the General Meeting. MC decides to meet in September to prepare the General Meeting of SHIF insured persons. In the meantime, SHIF insured persons shall be informed of the forthcoming General Meeting.

Item 7: External Audit of the SHIF

ES presents the report on the audit work carried out by the External Auditors on the 2014 SHIF accounts. ES informs MC that the 4-year mandate of the Office of the Auditor General in Canada has expired, and that since 1 January 2016, and for a 4-year period, SHIF accounts will be audited by the new External Auditors for the ILO (the Commission on Audit from the Republic of the Philippines). ES will check with the new External Auditors if they would agree to make a presentation to the SHIF Management Committee.

ES invites MC members to provide comments to the latest draft sent to them on 1 July, after which the report will be sent out for translation and publication.
