Background

This event is organized on the occasion of the official launch of the <u>first edition of the Global Employment Policy Review (GEPR)</u>. This major publication of the ILO examines trends in employment policies while at the same time presenting new and innovative solutions to the challenges of policy design and implementation. The GEPR focuses on the role of employment policies for the process of structural transformation.

Building on the third ILO Symposium in 2019 where the ideas for the first edition of the GEPR were presented, final results will be shared and discussed during this webinar, with a specific focus on the importance of policies not only for structural transformation processes but also for putting economies on the right recovery track towards a better future of work after the COVID-19 crisis. In addition, the purpose of the webinar is to bring the discussion forward to reflect on the importance of employment-centred macroeconomic policies and active labour market policies — which will be the focus of the second edition of the GEPR. In this sense, this webinar serves the purpose to build a bridge to the next Employment Symposium to be held later this year as well as to the second edition of the GEPR to be launched in 2022.

Objectives

- Present findings of the first edition of the GEPR in light of the current crisis;
- Get inspiration for the second edition of the GEPR with its focus on employment-centred macroeconomic policies and active labour market policies;
- Further foster the global knowledge network amongst policy-makers, academia, international organizations, other UN agencies and development partners as a continuation of the ILO Employment Symposia.
