16.d.	Covid 19 has posed a challenge in most economies and Kenya has not been spared as job losses have become prevalent and collective bargaining even suspended in some cases.
16.g.	Most of the jobs created are in the informal economy, which can be precarious because the method of payment is based on production and they are usually family or individual businesses. Current jobs being created are in the GIG economy which is difficult to organize.
16.h.	The government has recruited more than 100 in 2021 Labour Administrators who are not trained in Labour Administration and are likely to face challenges and difficulties in respect, promotion and realization of freedom of association and
